Pyrotek Firefighting Suit consisting of Jacket (Pyrotek Art No. 1879139) and Trouser/pant (Pyrotek Art No. 1879138).

These garments have the following four layer construction: Meta aramid fabric outer layer, Moisture barrier layer, Meta aramid felt thermal barrier layer and Meta aramid fabric lining.

The jacket has a band of reflective tape encircling: the chest, both forearms and the lower torso at hip level. The bib & brace style trousers have a band of reflective tape encircling each leg at shin level.
